Rules Committee Update:

Division 1- Coed-was proposed to use multi-wall bats. The Division 1 managers were sent an email to see what they think about being able to use the multi-wall bats. Two teams agreed and one did not. It was discussed that maybe we should poll all the coed teams to see if they were interested in using the multi-wall bats in their divisions as well.
