**Covid-19 Response:** The committee met last week, and the minutes were sent to the board. Was decided if the Governor says we are in the Phase II (starts May 8<sup>th</sup>) we will continue with the registration close on May 13<sup>th</sup>, Classifications May 14<sup>th</sup>, Start June 1<sup>st</sup>.

If we are not in Phase II but in Phase III (starts May 22) then we will have the registration close on May 27th, Classifications May 28th, Start June 15<sup>th</sup>.

The committee is watching the mandates and have been meeting regularly to discuss. Traci and Bob had a meeting with USAA last week and they said Anchorage is waiting on the mandates as well, but they have cancelled all the May tourneys up north. It is up to JSA if we want to have our Draft tourney end of May-

depends on what the mayor says. Some things that Anchorage and Traci brought up to maybe do this season if we are able to play is sanitize the bats, balls and gloves after each inning; sanitizer in dugouts; wear masks and gloves; rule where catcher is 6' from batter and umpire is 10' from catcher or batter off to the side. Was suggested if we did that, we might need to use the strike mats since the umpire will be too far back to see the ball land. Was also mentioned to take away stealing this year since that could cause people to come in contact with each other and to put lines off the side of the bases so runners just need to cross the line to avoid having to tag.

These are all suggestions that the committee will discuss, nothing is mandated at this time. we just need to figure out how to be able to play. We will need to talk to CBJ and JDOA about how to do this. The next meeting is on Friday the  $8^{th}$ .

We have sent the list of days and divisions to Everett to review for his scheduling since we will have a very short window to get the schedule out. He will talk to his umpires about when they can umpire.

We are still planning to go forward with the Super Draft tourney end of May if possible. We will need to start taking about it and getting people signed up. Was agreed we will talk about it in the Managers meeting.

We will have the Managers Meeting via WebEx on May 21<sup>st</sup> at 6pm, even if we are not in the Phase II. We will try to get as many managers online as possible and we will need to have a plan of what we are doing to be able to play. We will record the meeting and post it online and on Facebook for managers who did not attend or ones that just signed up (if the registration was pushed to June 27<sup>th</sup>). We will also have a board meeting after the manager meeting. We will make sure to have the poll information back about playing on Saturdays before the meeting.
